I, the undersigned, The Team's Head Coach agree to the following requirements and certify to the following:

1. Attached is a certificate of liability insurance from The Team's US Soccer affiliated member organization or Foreign Soccer Federation naming the Illinois Youth Soccer Association (hereinafter known as IYSA) and The Tournament Host as additional insured in the minimum amount of \$1 Million.
2. Attached is proof that all of The Team's players and coaches are registered, insured and in good standing with the Team's US Soccer affiliated member organization or the Foreign Soccer Federation and have permission to travel and participate in The Tournament.
3. I understand and agree that The Team, its members and related individuals are not covered by IYSA insurance for incidences arising out of The Team's participation in The Tournament.
4. Attached for each of The Team's players is a completed and signed IYSA Emergency Medical Release & Liability Waiver.
5. I certify that for all of The Team's players and coaches have a current valid player pass from The Team's US Soccer affiliated member organization or Foreign Soccer Federation. I understand that I have to present these passes to The Tournament at check-in, prior to The Team's first tournament game. I understand that these passes must be laminated and contain the coach's photo on the coach's pass and the player's photo and date of birth on the player's pass.
6. Attached is a copy of The Team's certified, current, official US Soccer affiliated member organization's or Foreign Soccer Federation's roster.
7. Attached is a copy of The Team's completed IYSA Tournament Roster. I agree that only the players listed on the Tournament Roster may participate in The Tournament, that no roster changes will be permitted during the course of The Tournament and that the number of players on the roster cannot be more than allowed by the IYSA rules. I understand that the maximum number of players per team including guest players is as follows: fourteen (14) for U11 or younger teams; eighteen (18) for U12 thru U16 teams; and twenty-two (22) for U17 thru U19 teams. The maximum number of guest players per team shall be specified by The Tournament rules.
8. Attached is a statement designating The Team's participation level that accurately corresponds to the levels specified by The Tournament.
9. For each of The Team's players that is an IYSA/US Youth Soccer currently registered player, attached is a copy of the IYSA Guest Player Form indicating permission is granted for The Team to use this player with The Team in The Tournament by the player's IYSA/US Youth Soccer's registered team coach.
10. For all adults associated with The Team (coaches, trainers, administrators) attached is a completed IYSA Disclosure Statement and I certify that The Team is in compliance with the IYSA Risk Management Policy.
11. By my signature below, I agree that I and everyone affiliated with The Team shall not recruit players at The Tournament.
12. By my signature below, I agree that I, The Team coaches, players and everyone affiliated with The Team shall abide by the policies, rules and regulations of the IYSA.

*I, the undersigned, agree to abide by all the requirements set forth in this Agreement and certify that the information provided by me is true and correct. I acknowledge and understand that the players and coaches of The Team are not covered by IYSA insurance for injuries and claims arising of The Team's participation in this IYSA sanctioned tournament (The Tournament) and further certify that I have insurance coverage for all of The Team's members from the US Soccer affiliated organization or Foreign Soccer Federation. I further understand that neither the IYSA nor US Youth Soccer or their Affiliates are liable for transportation, lodging, or injury to persons or property sustained in the course of this approved event. On behalf of The Team I also agree to defend, indemnify and hold harmless the IYSA, its officers, directors, coaches, managers, employees, agents, associated personnel, affiliated organizations, and sponsors from and against any and all liabilities, losses, fines, penalties, costs, expenses and reasonable attorney's fees that arise out of any and all allegations asserted in any third party claim, demand, suit, or cause of action or proceeding arising out of any of the following, whether actual or alleged: (a) any bodily injury, including death, to persons or damage or loss of property which result in whole or in part from any act or omission of the IYSA and the Tournament Host relating to the IYSA and the Tournament Host carrying out its obligations under this Agreement; and (b) any breach of this Agreement.*
